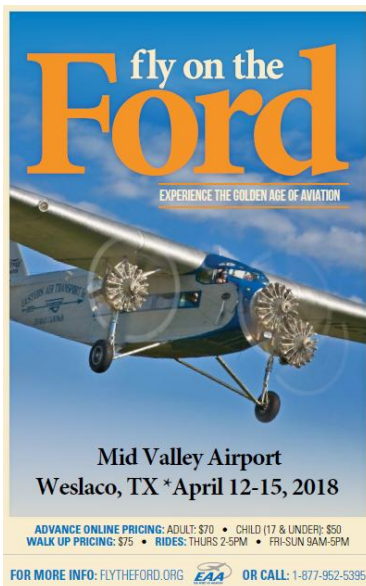

Old Business:
